Two operations against illegal VoIP establishment were conducted by a joint team of BTRC and RAB-7 at 7:30 PM on 4th June 2017, located at level-6, "BEST TULIP" House# 22, Road # 01, Hillview R/A, Nasirabad, Chittagong and at 11:00 PM. Of the same date located at House# 59 (6th floor) Road # 03, DOHS, Chittagong.

Two accused persons have been arrested for illegal VoIP activities. Criminal lawsuits have been lodged for such illegal activities under section 35(2), 55(7) of the Bangladesh Telecommunication Regulation Act, 2001. The materials confiscated during this operation are now under the police custody at "Panchlaish Thana" and "Bayzid Thana", CMP.
